Housing Benefit: What you'll get - GOV.UK

Your weekly Housing Benefit award will be calculated by taking 65% of your Excess Income (£ 75) from your weekly eligible rent amount. e.g. weekly eligible rent is £ 100 and your excess income is £ 75. Housing Benefit is £ 100.00 minus (65% of £ 75). So this is £ 100 minus £ 48.75 = £ 51.25 per week.
