Download Late Rent Chase Up Letter 1. Deal with non-payment of rent issues immediately. If rent is more than 3 days overdue, then send out this first letter. (Always take into account bank holidays, Christmas and Easter breaks because banks do not process any payments at these times). The final sentence of the letter talks about imposing an administration charge for late payment.

Your letter should request that the outstanding arrears be paid immediately and ask the tenant to ensure that all future rental payments are made in full and on or by the due date. You should explain that unpaid arrears could result in court action being taken against the tenant and state that you may make an application to the court for possession of the property should more than two months' rent go unpaid.
